GRANTS

John applied to the King for a grant of land in South Carolina, he may have not taken

possession of the property but his sons Thomas or Ichabod may have taken possession, as that is where they settled and lived. John also applied for land patents in Virginia which he may never have taken possession, but his son John Jr. may have taken possession, as that is where he settled and lived the rest of his life, as a large land owner. John Winburne Sr. did pay quit rents on the property in Virginia. There were many land grants in Virginia given to favored sons and to people willing to do duty for the King. There were weaknesses and abuses of the Virginia land system and it underwent a detailed analysis near the end of the seventeenth century by the newly created agency -The Lords Commissioners of Trade and Plantations which was commonly known as the Board of Trade. During the first year of its organization in 1696, the Board received a report from Edward Randolph, sent from England to be surveyor general of customs in America. Randolph pondered the question as to why the colony of Virginia was not more densely populated with all of the migration that had occurred. In an incisive statement he concluded that:

The chief and only reason is that the inhabitants have been and still are discouraged and hindered from planting tobacco in that colony; and servants are not so willing to go there as formerly because the members of Council and others who make an interest in the government have from time to time procured grants of very large tracts of land, so that for many years,

there has been no waste land to be taken up by

those who bring with them servants or by servants who have served their time. That is to say, the absentee landowners had gotten the

best tracts of land.

1687-John and his wife Elizabeth sold land with his father, William Winbourne in Malden, Mass.

Next we find John Winborne Sr. in Colleton County, South Carolina. John Winborne had a warrant for all that Tract of Land lying between the land lately belonging to John Jackson and the lands belonging to the Heirs of Paul Grimball, Esq., Lately deceased. Dated the 8th of March 1696/7 (From Warrents for Land in SC. 1692-1711 by A. S. Salley, Jr. Vol. 2, pg 141.)

In the year 1704 John Winbourne paid Quit Rents of Virginia to the King for 400 acres. King George granted to Henry Holland 230 acres in the Upper Parish of Nansemond Co, VA, adjoining John Holland, Jon Winborne, Jr. and Ann Ballard, June 1720

Quit Rents were an early form of property tax assessed by the Crown of England.

The Quit Rents of Virginia, 1704 compiled by Annie Laurie Wright Smith.

The warrants had to be granted by the King of England.

OTHER INTERESTING FACTS:

From the book, "The History of the Town of Manchester Essex County, Mass." by Lamson, we find the following: (sp. as found) "One of the first things with our fathers was a care for the maintenance of a gospel ministry. Life without the institutions of religious worship would have been a meagre thing. The church was the centre around which all the interests of the community revolved. The first meeting in town for public worship according to tradition, was held under a tree on "Gales Point", but the name of the preacher around whom gathered the little band of settlers with bowed heads and reverent hearts, is lost in oblivion.

Dr. E. W. Leach has preserved, pasted on one of the leaves of his "Collections", a little scrap of yellow paper, giving in the handwriting of Rev. Ames Cheever the names of the early

ministers of Manchester; the record bears date, Nov. 20, 1726. The names are as follows: Ginners, Smith, Stow, Dunnum, Millet, Hathom, Jones, Winborn, Hubbard, Emerson, Goodhue, Eveleth, Webster.

Of most of these early ministers we have but very slight information, some of them may have only supplied the pulpit for a time. We know as much perhaps, of Ralph Smith as of any; and of him it may be said that we know too much. He is spoken of as "a man of low gifts and parts". Cradock warned the colonists against him adjuring them not to suffer him to remain "unless he be comfortable to our government". He was probably a man with too many defects of character to be useful in the ministry, and he soon laid down the office. John Winborn, who came in 1667, found his residence here far from pleasant. In 1686, the town voted "that he herewith provide for himself and family some other place"; after considerable altercation, the money questions involved were settled by compromise. On 11 April 1667 John Winborn married Elizabeth Hart of Watertown, Mass. She was the daughter of Isaac and Elizabeth Hart, born 11 Dec. 1651. The wedding took place at Malden, Mass., which had been settled as late as 1640, and was the town where the gloomy, colonial, strict Calvinist poet, Michael Wigglesworth preached for many years. Mr. Wigglesworth might well have preformed the marriage ceremony.

In 1669 John Winborne was granted 500 acres in Nansemond County, Va. He may have had a boat. His father William lived by the wharf and

so the boat may have belonged to him. The easiest transportation between the colonies was by boat. (We have no record of his actually having a boat, but this information points to that fact.)

After leaving the pulpit in Manchester, Mass. John applied to the king for a grant of land in South Carolina which was given him, although he may have never taken possession of the property. (One of his sons may have taken possession of the property.) The names of the early land-holders in the Wappetaw area include some names of the fifty-two New England Voyagers who settled there in 1696, among them was John Wlnbourne and his sons, Thomas and Ichabod and daughter Susanna who married Hugh Adams. His son John settled in Virginia. The New Englanders who settled on Seewee Bay in 1696 did not immediately organize Wappetaw Church. Dr. George Howe wrote, "The uncertain date" of the Congregational Church of Wappetaw belongs to the early part of the next century, and not to this. Be that as it may, the first record of a call from Wappetaw for a minister was in 1699, to the Rev. Hugh Adams. Rev. Hugh Adams married Susanna Winboume, daughter of John Winbourne, Sr. about 1700.

Another record found in the Adams Family History states: That on Oct. 22, 1695 at the church meeting in Dorchester Town, Mass, a church was organized for South Carolina and among those named to go was William Adams of Subbury. We later find him in South Carolina where he settled and became the ancestor for one branch of the family Adams. Of Interest was that a William Adams was captured by Blackbeard, the Pirate, and was released and later settled in Colleton County, S. C. The reason he was captured by Blackbeard

was because the best way to travel was by ship between the colonies. Many of the early colonists were skilled boats men.

Ex-Judge, Benjamin B. Winborne in his book, "The Winborne's of Old" wrote: about John: "John Winborne, of Suffolk, Va., was the oldest one of the family of whom we have any record. He was a large landowner in his county and a man of much prominence. He was one of the vestry men of the old Episcopal Church at Suffolk from 1743 to 1754, and a church warden in 1748, as shown from the old vestry books above mentioned. In 1746 he voted in the vestry to rebuild the old brick church at Suffolk which was repaired and completed in 1748. In 1750 he was made one of the processioners of the parish, which was the same as surveyor-general under the colonial laws of North Carolina. These places were filled by the ablest men of the parish." The law of Virginia in reference to their elections and required qualifications is found in Hening's Statutes at Large of Virginia, and reads as follows:

"That for the making and proportioning the levys and assessments for building and repairing churches, and chappels, provisions for the poore, maintenance of the minister and such other necessary duties for the more orderly

managing all parociall affairs, be it enacted that twelve of the most able men of each parish be by the major part of the said parish chosen to be vestrymen out of which the minister and vestrymen to make choice of two church wardens yearly; and that none shall be admitted to be of the vestry that do not take the oath of allegiance and supremacy to His Majesty subscribe to be conformable to the doctrines and discipline of the Church of England." Hen. Sts. at Large, pg. 44. The church wardens were required to present to the courts of the parish, twice a year, all persons who had committed misdemeanors in the parish. They took the place of our grand juries. They were also required to look after the repairing of the churches, furnishing the churches with books, ornaments, a great Bible, prayer books, communion cloth and napkins and the like. Hen. sts., pp 51 & 52 Processioners were appointed by the courts. "Two honest and able surveyors" were selected for each parish, and the vestry divided their parishes into precints, and had the lands processioned between Easter and Whitsunday. Henning Sts., p 102. From the above facts, which were taken from the old vestry books in the library of the

the old vestry books in the horary of the theological Seminary of Fairfax County, Va., it appears that the old members of the Winborne family of Nansemond County, Va., were not only landowners, but were among the best and ablest people of the parish."

OTHER INTERESTING FACTS

From the book "Churches, Ministers and Families of Virginia" by Bishop Meade "Having thus availed myself of the journal of

Colonel Byrd and the report of Mr. Griffin concerning the Indian School, and Mr. Anderson's account of the Church in North

Carolina, I return to the brief sketch of the Church in Nansemond. It was divided into two parishes, - the upper and lower. The lower was sometimes called Suffolk parish, although the town of Suffolk was in the upper parish. All that I have yet learned of the Suffolk or lower parish is, that there are two old brick churches in it, one on the left and the other on the right bank of the Nansemond River, each about ten miles from Suffolk. There is a valuable glebe attached to them which, being a private donation, has not been touched. There is no minister in the parish.

The vestry book of the upper parish dates back as far as November 30th, 1743. At the first vestry meeting there were present Colonel Andrew Meade, Edward Norfleet, Lemuel Reddick, John Gregorie, John Norfleet, Daniel Pugh, Jethro Sumner. In the year 1744 Captain William Wright and Captain Williams appear on the list, and the Rev. Mr. Balfour is arraigned by the vestry for drunkenness, swearing, and other vices, and nothing more is heard of him. In the year 1746 Henry Temple, Christopher Norfleet, Miles Reddick, and Mr. Winburn are vestryymen. In this year a new brick church is ordered in Suffolk in the place of the old one. In the year 1747 the Rev. Willis Webb is elected minister, Richard Baker chosen vestryman, and a chapel at holy Neck ordered, - the minister to preach at Middle Chapel and Somerton Chapel until the new chapel is built."

From "The Vestry Book of the Upper Parish" Ordered that William Baker, John Winbourn, Lemuel Riddick, Christopher Norfleet, and John Ralls or any three of them Indeavour to Purchase two Acres of Land from Hardy Ralls at a place called Holy Neck on the Back swamp for a place to erect and build a Chappell on, for the use of this Parish and that a Deed be made

to William Baker Gen. in Trust for this Parish and that the Same be recorded as Soon a Possable and the Said William Baker, John Winbourn, Christopher Norfleet, John Ralls and Lemuel Riddick are hereby Appointed Directors and Trustees for Carrying on the building a Chappell at the Said Holy Neck as Soon as they Can get Sufficient Deed for the Land the Chappell to be of the following Dimensions to be built with a good Fraime, Plank Walls & well Shingled of the Length of fifty feet. The Wedth Twenty Six feet, the pitch fourteen feet. with a Galire at on End the whole to be compleated as Soon as Can be after the Usuall Manner of Building Chappells that the Said Trustees Imploy some Person or Persons to build the Same & that as often as they Shall have Occasion of Money for Carrying on the Said Work they Draw on the Church wardens for Money for that Use and that the Said Trustees Account with the Vestry when required and Render an Acco. of their Actings & Doings

Ebenezer could sign his name and he apparently could read and write as he was put

in charge of the by-laws of the town. His father, John and brothers and sister moved to South Carolina, but Ebenezer stayed in Boston. His sister Susannah and her husband Hugh Adams

came back to Boston.

He married first, Lydia Prince in 1706 by Mr. James Allen. He married second, Elizabeth Qwinn in 1744 by Rev. Thomas Prince. **1723 - 1758** He was a watchman in the south end of Boston.

1737 - 1738 He was hired to run a pest house (small pox) as a guard at Ramsford Island Quarantine, it was lifted and he was released from duty. Then he was a watchman and overseer of the poor, pesthouse and etc. Was

paid for back wages. From "Selectman's Minutes 1737-38" Pages 36,85, 95, 96, 99, 113, 100, 141,177, 180, 246, 249, 272.

1737- "City Document No. 87"- Voted that Ebenezer Winburne be and hereby is appointed to join with and assist M. Cowdrey in taking care, that the By-Laws of the Town are duly put in Execution, For the Space of One Month next coming.

Mr Savell Reporting that he had been on board the Sloop Neptune lying near Spectacle Island, and made strict inquiry about her, and was inform'd

That the Boy who has been sick of the Small Pox on board said sloop was Carried to Rainsford Island with his Chest, his Bedding and Clothes; that the Sailors Bedding had been Carried on Shore at Spectacle Island and well Aired; That they had carefully cleansed and Smoke'd the said Sloop According to Order. Wherefore. Voted, That it is our opinion the Said Sloop Neptune may be permitted to come up to the Town without Danger to the Inhabitants provided the Oyle and the Hemp part of her Loading, Together with the Bedding of the Sailors etc. be left at Spectacle Island until further Order, and a Certificate was

delivered to Capt. Davis Accordingly. Upon information that Jabez Bacon died last night at Rainsford Island of the Small Pox. Voted That M. Savell be and hereby is directed to cause a

Coffin to be for with made for the said Jabez, And that Winburn with two more persons be sent down to said Island to take care of Burying the said Jabez, at a remote part of the Island, who are Ordered to make the Grave Six feet down at least.

Susanna Winbourn b. 1675

(Susanna, Elizabeth, Isaac)

Susanna was born 1675 in Manchester, MA, and died in Mass. She married Hugh Adams, son of John and Avis Adams.

History of the town of Durham, Vol.2, page 4 Rev Hugh Adams was born 7 May 1676, graduated at Harvard in 1697. The next year he went to South Carolina, where he was pastor of several churches, and remained there till 1706. In a letter he states that "our precious godly mother Avis Adams departed this life October 6th last" (1699). This was at Charleston. [See Mass. Hist. Coll. Vol. VI., 5th series p. 12.] The Rev. Hugh Adams died in Oct. 1748, aged 72. [See chapter on History of the Church in Durham.] His widow, Susanna was living in 1766.

Tabitha was an invalid and died between August 20, 1860 and before the 1870 census. It is believed that her son Stephen, lived at home and supported her until her death Cornelius' birth date and place of birth is unknown, but family records say he was born in Guilford Court House/Greensboro, Guilford Co, NC. Guilford Court House was a small village of about 100 people that was inhabited mainly by Quakers. After the Revolutionary Battle there in 1781, between Cornwallis and Greene, the village never recovered. About 1801 the hamlet was no more and shortly thereafter, Greensboro was formed. Cornelius was born c1800.

"Your petitioner there prays that your worship will appoint a Magistrate and three freeholders whose duty it states is to go upon the premises view the same and after being duly sworn to allot, set apart, and assign over to your petitioner provisions on hand a full sufficiency for one whole years support for your petitioner and her family and in case of any deficiency in stock crop and provisions on hand this is of mav sufficient to complete a full years support for your petitioner and her family and that they lay off and _____to her a wheel (?) and one pair of cards. R. G aty".

1842 May Term,--Petition for year's allowance:

"This case coming on to be heard on the reading of the petition and argument and suggestion of the Counsel, it is declared by the Court that the petitioner Tabitha Winborn is entitled to have a full year's support and maintenance for herself and family out of the personal estate of her deceased husband Cornelius Winborn.

"It is therefore ordered by the Court that John W. Kirkman, Esq., with A. Hanner, Jos. Stanby, and Levin Kirkman three freeholders, to be appointed to on the premises of the deceased, view the same, and out of the stock, crop, and provisions on hand, to allot and lay off to the petitioner a full and sufficient quantity for the comfortable support and maintenance of herself and family for one year, and in case there be a deficiency of stock, crop, &c. on hand, then to assess a sume of money sufficient to make up said deficiency to complete a whole year's allowance, and in addition thereto, appropriate and lay off to your petitioner one bed and its necessary furniture, and one wheel, and one pair of cards, to be the absolute property of the petitioner, and put her in possession of the same; and that they report to the next term of this Court agreeable to an act of Assembly. Issued the 28th day of May A. D. 1842. John M. Logan C.C.C." 1842 August Term-Petition for year's allowance: This document is identical to the one above, 1842 May Term, but was Issued the 2 day of September A. D. 1842. 1842 November Term--John W. Kirkman, Justice of the Peace and the three freeholders named above "proceeded on the 3 day of Nov. 1842 to view the estate of Cornelius Winborn deceased and for the want of provisions we have allowed her one hundred and fifty Dollars Tabitha Winborn to be paid widdow of the Deceased to be paid her by the Administrator we have further laid off and

allotted to her one bed and its necessary furniture & put her in provisions of the Same and we further allow her the Sum of five Dollars to purchais one wheel and pair of cards to be paid by the sd Administrator." 1844 April 23--To the Sheriff of Guilford County: At the February Term 1841 Guilford Co, NC, "Boaz Adams obtained a judgement against Cornelius Winborn for the sum of Two Hundred & Seventy Four Dollars and Seven cents (\$274.07) with Int from the 20th October 1840 and costs . . . and whereas Boaz Adams as herein before stated of which execution yet remains to be done . . . " command you to make known to William Willis, appointed Administrator upon the estate of the said

Cornelius Winborn decd, to appear before the Justices of the Court of Pleas & Quarter

Session the 3rd Monday of May next to shew cause why said Plaintiff shall not have judgment against him as the Administrator aforesaid for the said judgment with interest & costs.

NOTE: It is not known if Boaz Adams ever collected---the final settlement of the estate did not show him as being paid. Mrs. Martha Adams was paid \$18.39 and Peter Adams was paid \$.75. In the Will of William Adams 1834 probated 1835, Cornelius owed him \$150.00 for rent due on his Shoe Shop. This may be the same family and the same debt--Bev.

1845 May 22--State of NC, Guilford County: "In obediance of an order of court to us the under Signed to Settle with William Millis, Administrator of the estate of Cornelious Winborn Decd we find as follows: (A two page list shows the names and amounts for all the claims collected) We find in the hands of the Administrator

Collected this amount \$392.28 (There is a list of 21 vouchers, the first being widows receipt for \$133.03) Also we find Vouchers in the hands of the Administrator as follows 453.76

We find a balance due the Adm'r of \$61.48 All the above we respectfully Submit to your Worships May 22nd 1845. David Wharton William S. Rankin
